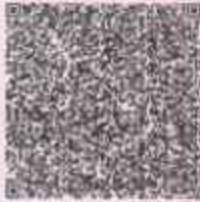

1. Whereas the founders are desirous of creating a Public Charitable Trust.

2. Now the presents witnesseth as follows:

1). The founders above named hereby establish a Public Charitable trust by the name of **"THINK INFINITY SCHOOL FOUNDATION"** educational charitable trust with the objects and upon the terms and conditions herein mentioned.

INITIAL TRUST FUNDS:

The Founders have this day contributed in all a sum of Rs. 7000/- (Rupees Seven Thousand Only) towards the Trust Fund as follows:

1. Sri Chivukula Venkataramana Rs.3000/- (Three Thousand Only)




2. Smt Chivukula Vijayalakshmi Rs. 2000/- (Two Thousand Only)

3. Ms. Chivukula Pravallika Rajyalakshmi Rs. 2000/- (Two Thousand Only)

3. **Trust Property:** The trust property shall comprise of the said initial fund as well as other amounts, securities, properties movable or immovable, which may be contributed or donated by the Founders, Members of the public or anyone else or from any other source and shall also include all additions, accretions, and acquisitions made by the trust and the income received by the Trust from time to time. Trust Property shall vest in the Trustees, herein upon Trust, subject to provisions hereof for the due fulfillment of the objects of the Trust.

4. **Office of the Trust:** The Principal office of the trust shall at present be Flat No. 2A, Priyawoodz Apartment, New Balaji Colony, Tirupati - 517501, Andhra Pradesh, India.

5. **Nature of the Trust:** This trust shall be a public charitable trust having no commercial or profit motives. It shall be maintained and administered to promote education, medical relief, a home for old age people and physically challenged and any other objects of general public utility. The benefit of this trust shall ensure to all sections of public in India without any distinction. The trust property including its funds and income shall be applied solely towards promotion of the objects for which this Trust is established.

(m) To grant scholarships and freeships and free food to the poor and deserving students.

(n) To establish, maintain, run develop, improve, extend, grant donations for and to aid assist in the establishment, maintenance, running, development, improvement and extension of libraries, reading rooms, recreation centers, bala vihars and all other facilities to be of use in imparting education to the public.

7. The trust shall be managed by the trustees consisting of

The total number of the trustees shall not exceed SEVEN.

8. The managing trustee only can appoint additional trustees within the number mentioned above.

9. The trustees shall confirm to be provisions of the Indian Trust Act 1882 in all matter not expressly provided for herein.

10. The trust hereby created is not revocable at the instance of the founders of the Trust at any time and under any circumstances.

11. The board of trustees shall be entitled to sue in the name of the trust and may similarly be sued in the name of the trust.

12. The trustees shall be competent and are hereby empowered to:

- (1) Receive any more and further assets in any shape or form as and when given by the founders of the trust, any of the trustees or any other persons or institutions.
- (2) Collect funds by donations, subscriptions, grants, presents or contributions.
- (3) Invest the funds to the extent necessary in accordance with the provisions of Section (13) read with section 13(5) of the Income Tax Act 1961, or such other sections of the Income Tax Act as amended from time to time so that the income of the Trust will be exempt from Income Tax.
- (4) Acquire on lease, purchase, or otherwise in any other manner, properties (movable or immovable), construct buildings and effect other improvements for the purpose of the Trust.
- (5) Help and render relief to the poor in all possible ways.

- (6) Make donations or contributions for attaining and in furtherance of the objects of the Trust.
 - (7) Meet necessary expenses to be incurred in connection with the execution and administration of the Trust.
 - (8) Establish centers in different parts of the country and world for carrying out the objects of the Trust.
13. Do all or any of the aforesaid things, transactions or matter and do all such other things as are incidental or conducive to the attainment of the aims and objects of the Trust.
14. None of the powers enumerated above will be deemed to authorize the carrying on any activity for profit by the Trustees and these powers shall be exercised by the Trustees in such manner that the income of the Trust will be totally exempt from tax under sections 11, 12, and 13 of the Income Tax Act 1961, or such other sections or clauses as amended from time to time.
15. All or any of the powers vested in or exercisable by the Trustees as per this Deed of Trust shall be capable of being performed or exercised by a majority of the Trustees present at the meeting of the Trustees and any action or decision of such majority shall be valid and effective as it would be done by all the Trustees.
16. The Trustees, if they choose and for the benefit of the Trust may delegate by means of resolution in writing any or all of their powers to any one or more of them or any other person for such time and purpose as they deem fit.
17. The Trustees shall take charge of the Trust assets and hold and administer the same in accordance with the term of this Deed. The Trust Board shall open one or more bank accounts in the Name of the Trust and all income, subscription and pecuniary donations for the general purposes for the Trustees and the income out of investment and all other moneys from time to time forming part of the general revenue of the Trust may be paid into a bank account or accounts. The Bank account or accounts shall be operated by the Managing Trustee individually or by any one of other founder Trustee(s) as may be determined by the Trust Board from time to time. The Trustees herein shall have power to borrow from the bank(s) on such terms and conditions as they decided from time to time.

19. Any Trustee may, at any time resign his/her office of Trusteeship by giving one month's notice in writing to his/her co-trustees and upon expiry of the period, such Trustee shall be deemed to have vacated his/her office. The office of the Trustee falling vacant either by death or resignation or revoke by board of trustee may be filled by nomination by the Managing Trustee of the Trust.

21. Any decision taken by the Board of Trustees is final, any of the Trustee should not question or challenge the decision made by board of trustees in any manner.

23. The Trustees shall cause true and correct accounts to be kept of the sums of money and other assets received and expended on behalf of the Trust. Once at least in every year, the accounts of the Trust shall be audited by a chartered accountant appointed by the Trustees. The financial statement shall be counter signed by the Chairman and one of the other Trustees of the Trust. The financial year of the trust shall be 1st April to 31st March of every year. The first final year of the trust shall close on 31st March, 2025.

24. The office of the Trustees shall be honorary, but the Trustees will be entitled to be paid their actual travelling expenses and other incidental charges incurred by them in attending the meetings and in connection with carrying out the objects of the Trust.



25. The Trustees are wholly indemnified against any expense of losses incurred or suffered in regard to any act, deed or omission of theirs in the performance their duties as Trustee, or any payments made by them in the administration of the Trust and such, expenses, losses and payments shall be borne by the Trust and none of the Trustees shall in any way be personally liable or responsible for the same.

26. The rules governing the administration of the Trust may be amended by the Trustees with the permission of the Commissioner of Income Tax, so however, that the amended rules are not inconsistent with the objects of the Trust and not repugnant to the provisions of Sections 2 (15), 11, 12, 13, and 80-G of the Income Tax Act 1961, or such other sections or clauses as may be amended or added from time to time governing the activities of public charitable trusts.

27. The benefits of the trust shall be open to all irrespective of caste, creed or religion.

28. The funds and income of the Trust shall be solely utilized towards the achievement of objects and no portion of it shall be utilized for payment to trustees by way of profit, dividend etc.,

29. In the event of dissolution or winding up of the Trust, the assets remaining on the date of dissolution shall under no circumstance be distributed among the Trustees but the same shall be transferred to other Public Charitable Trust or having similar objects and aims.
